Full payment should be included with your completed application for the number of tables desired. We are usually sold out from show to show. We do not take deposits. Your payment is not deposited until we confirm with you that we have space and that you confirm that you want it. Once you have a table with us, we provide an additional option to renew from show to show and take a 10% discount off our normal table rates.

Every dealer on the bourse and behind a table must be a member of the GNA and be in possession of a dealer badge. Annual GNA membership dues are \$10, billed in November of each year. Table rental fees **do not** include GNA dues. Also, single table rental includes 2 badges, corner tables 3. Additional dealer badges up to the maximum number of 6 per table configuration may be purchased for \$25 each **in advance, or \$35 each at the show.** Add-ons to your table at the show, even if to your allotted 2 or 3 free badges, require a \$25 "change" fee. To avoid additional fees, please reserve your extra badges or complete name changes prior to the show. If you don't order from Richard and Gary, they will not be available. There will be an order form in your 2012 confirmation packets, as usual.**

The GNA coin show is at the Northwest Georgia Trade & Convention Center, Dalton, GA. Dealer move-in begins at 1:00 PM Thursday, April 26, 2012 and ends at 8:00 P.M. Bourse will open to dealers with badges at 8:30 AM April 27- April 29, and close at 7:00 Fri/Sat., 5:00 on Sunday. The bourse area will open to the public with guest badges at 10:00 AM Fri-Sun, and closes at 6:00 P.M. Fri/Sat, then 3:00 P.M. Sunday, April 29 2012. Insurance against loss of material is the responsibility of the dealer. Uniformed police officers will provide security from 12:00 noon, Thursday, April 26 through 5:00 PM Sunday, April 29, 2012. Bourse area must be vacated by all dealers no later than 5:00 PM Sunday, April 29 when security retires. Early Bird badges (\$40) will allow bourse access starting at 3:00 Thursday, then same hours as dealers Fri-Sun, subject to revision.

Dealers must comply with the GNA Code of Ethics (copy available upon request). No dealer may knowingly exhibit or offer for sale any illegal coins, unmarked counterfeits, forgeries, or copies, or other spurious merchandise. Any such infraction of this rule shall be construed as being against the best interests of numismatics and the GNA. Penalty can be immediate ejection of the dealer from the bourse floor and possible suspension and/or subsequent expulsion from the GNA.

Make checks payable to **Georgia Numismatic Association.** After receipt of full payments and reassignment of any non-renewed tables in February 2012, a confirmation letter with assigned tables and show information will be mailed around March 1st. Cancellation Policy: (1) Notice of cancellation must be in writing. (2) Full table payment is due by January 15, 2012. A 10% late fee will be assessed for payments, if accepted, after this date. Any reserved tables **not paid in full** by January 15, 2012 will be subject to reassignment at the sole discretion of the GNA. (3) For notices of cancellation received prior to the payment due date, 100% of any payment made will be refunded, less a 10% processing fee. (4) For cancellations received 60-90 days prior to show, 75% refunded. (5) For 30-60 days out, 50% refunded. (6) Inside of 30 days there are no refunds. (7) The GNA reserves the right to reassign table numbers at its discretion. (8) Dealers are expected to check-in at registration no later than noon on Friday, and occupy their tables until the close of the show on Sunday @ 3:00. Requests for late check-in or early departure will be honored at the discretion of the GNA. Dealers not checked in by noon on Friday, will have their table(s) rescheduled/resold at the sole discretion of the GNA with no recourse to the original dealer. Our special circumstances "roll-over" reservation option is for **free** table space the following year, and is not eligible for future refund when implemented. Roll-over can not be used consecutive years. No assigned table(s) can be sublet.
