Every dealer on the bourse must be a member of the GNA and be in possession of a dealer badge. Annual GNA membership dues are \$10, billed in November of each year. Table rental fees **do not** include GNA dues. Also, additional dealer badges up to the maximum number of 6 may be purchased for \$25 each **in advance** without incurring late charges. Single table rental includes 2 badges, corner table rental includes 3. You may purchase up to 3 additional dealer badges. There is a \$25 fee for all changes made during the show. The GNA coin show is at the Northwest Georgia Trade & Convention Center, Dalton, GA. Dealer move-in begins at 1:00 PM Thursday, April 15, 2010 and ends at 8:00 P.M. Bourse will open to dealers with badges at 8:30 AM April 16 - April 18, and close at 7:00 Fri/Sat., 5:00 on Sunday. The bourse area will open to the public with guest badges at 10:00 AM Fri-Sun, and close at 6:00 P.M. Fri/Sat, 3:00 P.M. Sunday, April 18 2010. Insurance against loss of material is the responsibility of the dealer. Uniformed police officers will provide security from 12:00 noon, Thursday, April 15 through 5:00 PM Sunday, April 18, 2010. Bourse area must be vacated by all dealers no later than 5:00 PM Sunday, April 18 when security retires. Early Bird badges (\$40) will allow bourse access starting at 3:00 Thursday, then same hours as dealers Fri-Sun. Don't forget the dealer and Early Bird reception at 6:00 P.M. on Thursday at our host hotel. Reserve your tickets at check-in.

Dealers must comply with the GNA Code of Ethics (copy available upon request). No dealer may knowingly exhibit or offer for sale any illegal coins, unmarked counterfeits, forgeries, or copies, or other spurious merchandise. Any such infraction of this rule shall be construed as being against the best interests of numismatics and the GNA. The penalty for such action shall be immediate ejection of the dealer from the bourse floor and possible suspension and/or subsequent expulsion from the GNA.

Cancellation Policy: (1) Notice of cancellation must be in writing. (2) Full table payment is due by January 31, 2010. A 10% late fee will be assessed for payments, if accepted, after this date. Any reserved tables **not paid in full** by January 31 2010 will be subject to reassignment at the sole discretion of the GNA. (3) For notices of cancellation received prior to the payment due date, 100% of any payment made will be refunded, less a 10% processing fee. (4) For cancellations received 60-90 days prior to show, 75% refunded. (5) For 30-60 days out, 50% refunded. (6) Inside of 30 days there are no refunds. (7) The GNA reserves the right to reassign table numbers at its discretion. (8) Dealers are expected to check-in at registration no later than noon on Friday, and occupy their tables until the close of the show on Sunday @ 3:00. Requests for late check-in or early departure will be honored at the discretion of the GNA. Dealers not checked in by noon on Friday, will have their table(s) rescheduled/resold at the sole discretion of the GNA with no recourse to the original dealer. Our special circumstances "roll-over" reservation option is for **free** table space the following year, and is not eligible for future refund when implemented. Roll-over can not be used consecutive years. No assigned table(s) can be sublet.
